

Milan Stallion Breeding Contract for Evincele

1. This agreement is made between Milan Quarter Horses, LLC and _____, the mare owner, whose address and phone are:

2. The mare owner agrees that he/she is the registered owner or acting agent of the registered mare.
Registered name of mare _____ Reg. # _____.
3. The mare owner and Milan Quarter Horses, LLC agree to breed the above mare to Evincele for a PRIVATE TREATY breeding fee (\$ _____). This includes a one-time initial Collection and Chute fee of \$350 during the 2019 breeding season. A non-refundable booking fee of \$300 is payable prior to any shipment of semen. If bred on the farm, the balance of the fee is paid when the mare is settled in foal at the farm. Any breeding's of the mare at Milan Quarter Horses in Athens, Texas will be at a dry rate of \$18/day and a wet rate of \$21/day.
4. Shipped semen. There will be a \$225 fee per shipment if it is sent Federal Express. If the semen needs to be sent counter to counter, the charge will be \$325. If the mare does not settle on the first shipment, each additional collection will be at the same collection fee and chute fee of \$350. Semen collections are on Monday, Wednesday, and Friday and we ask to call as earliest as possible for delivery. Please call Saginaw Valley Equine Clinic @ 989-790-7339 and ask for Carissa Rodarte or Dr. Sarah Eaton.
5. The contract contains a "live foal guarantee". A live foal is described as a newborn foal, which stands and nurses without assistance. If a foal is born dead, there are return privileges for the 2020 season only if the stallion owner is notified within 7 days and receives a veterinarian statement regarding the death. If after the mare is pronounced safe in foal and should the mare miscarry, the mare owner can return for the 2019 breeding season for the original breeding service and chute fee of \$350 along with the original shipping fees. The same applies should mare owner wait until the 2020 breeding season to re-breed mare.
6. A "Breeders Certificate" will be issued for the foal, conceived by this mating, when stallion fee and all related cost have been paid by the mare owner and a live foal has been produced.
7. Both parties agree that Milan Quarter Horses, LLC and their employees and acting veterinarians are not liable for accidents, sickness, or death to above named mare while in the care of the stallion owner. Milan Quarter Horses, LLC will exercise the best judgement in care and supervision of the mare and its foal.
8. Should the mare die, the mare owner shall be entitled to a re-breed to another mare at a cost of \$600 plus the breeding collection and chute fee of \$350 and the associated shipping.
9. This contract is non-assignable and non-transferable.
10. When both mare owner and stallion owner sign this contract, it will then be a binding contract subject to the above terms and conditions. This contract is entered into the state of Texas and will be enforced under the laws of Texas.
11. At this time we only accept payment through PayPal or by personal check. Personal checks need to be mailed to 7039 Lake Edge Drive, Dallas, TX 75230.
